

2025 Equity in Athletics Disclosure Act (EADA) Report

Any coeducational postsecondary institution that participates in the Federal student financial assistance programs and has an intercollegiate athletic program is required by section 485(g) of the Higher Education Act of 1965 (HEA), as amended, 20 U.S.C. 1092(g) (also known as the Equity in Athletics Disclosure Act, or EADA), to report certain information regarding intercollegiate athletics. The EADA was designed to make prospective students and prospective student-athletes aware of an institution of higher education's commitment to providing equitable athletic opportunities for its men and women students. The EADA requires the disclosure of information about varsity teams and the financial resources and personnel that the school dedicates to those teams. There are two EADA reporting requirements that institutions must meet to comply with EADA:

- (1) Annual EADA Report - This report must be published by October 15th of each year and must be available upon request to students, prospective students, and the public.
- (2) Annual EADA Survey - Institutions must submit EADA data to the Secretary of Education within 15 days of making it available to students, prospective students, and the public through the EADA Report.

The annual report, officially called *The Report on Athletic Program Participation Rates and Financial Support Data* and commonly referred to as the EADA Report, must include information on:

- the number of male and female full-time undergraduates students (Table 1),
- the number and gender of participants and coaches (Tables 2-8),
- the annual school salary of non-volunteer head coaches and assistant coaches for men’s and women’s teams (Tables 9-10),
- the total amount and ratio of athletically related student aid awarded to male athletes compared to female athletes (Table 11),
- the expense incurred by the school for men’s and women’s sports (Table 12), and
- the total annual revenues for men’s and women’s sports (Table 13).

The tables below summarize the information required. This data is for the 12-month reporting period of 7/1/2024-6/30/2025.
